The vehicle is lying in the office garage of above ICDS project campus, which can be inspected during the office hours in between **10 AM to 5 PM on any working day till 08.01.2012**.


Persons intending to participate in the auction sale should deposit earnest money of **₹ 2500/- (Rupees two thousand five hundred)** only for the above mentioned vehicles in shape of bank draft in favour of the District Social Welfare Officer, Kandhamal **on or before 09.01.2012**. The bidders are required to produce necessary money receipt for participation in the auction sale. The earnest money will be refunded to the unsuccessful bidders immediately after the auction sale is over.

After the confirmation, the highest bidder of each vehicle should deposit 25% of the bid amount on the spot with the DSWO, Kandhamal and the highest bidder should deposit balance amount within seven days from the date of conformation of the bid. If the bidder fails to deposit the full bid amount within the stipulated period, the deposits including earnest money shall be forfeited and fresh sealed quotations will be invited for disposal of the vehicle.

The auctioned vehicle must be removed without spare parts, tools, etc. from the garage of the above ICDS project by the bidder within in 7 days from the date of depositing of the full bid amount. It will be the responsibility of the bidders to look after the vehicles at their own expenses and the department will not be held responsible for any damage, pilferage or otherwise no claim on this amount shall be entertained. In case the vehicle is not lifted within the prescribed time limit, ground rent at @ 1% of the bid amount for each day to delay will be charged.
